We only share data with trusted service providers (e.g., IT support, payment providers, Technogym, Clubright) and

authorities where legally required.

-Your Just Move account and any associated direct debits are administered using a database system provided by our

partner, Clubright. Clubright use London & Zurich to administer direct debits collections. London and Zurich receive your

name, bank account information and direct debit value in order to process and take out any direct debits you take out.

Club Right have access to our database and the personal information contained within it for administrative and maintenance

purposes only. They will only share information that is necessary with third parties named below for the purpose of

delivering customer service.

-Just Move use SUMUP for the purpose of making card transactions. When you make a payment SUMUP receive card

details only to take the payment.

-Just.Move Gyms uses Technogym as its fitness equipment provider. In order to gain access to your Technogym account,

your Membership information, including name, email address and date of birth are passed to Technogym via Clubright for

the purpose of creating one synced account. Technogym accounts will be created automatically as part of Just.Move Gyms

membership . Should you wish to delete your Technogym account, however, you can contact:
